My Brothers and Sisters.

This newsletter will undoubtedly upset half of its readers. So be it. Things need to be clarified, and it is past time.

I am going to lay out some facts that many won't know. Because too many have isolated themselves in bubbles and echo chambers of misinformation.

After a worldwide pandemic and worldwide inflation, the United States currently has the best economy in the world. Last month, the World Bank stated that the US is helping to buoy other countries' economies around the world. Inflation is down to 2.5% - the lowest in the world. Unemployment is at record modern low – the lowest in the world. Gas prices are down dramatically. Violent crime rates are at a 50-year low. Border crossings are currently at the lowest point in years. And if Harris-Walz win they will pass the Bi-partisan Border Security Bill - that Trump torpedoed months ago. The bill the Border Patrol Union said would be the biggest boost to border security ever. More Americans have health coverage today than ever before. Medi-

care and major drug prices have been capped by the Democrats. The stock market is hitting record highs weekly. The US isn't deployed in any foreign wars. Domestic manufacturing is stronger than it has been in 50 years. Manufacturing jobs have come back to the US in record numbers. Energy production is at an all-time high. We are no longer an oil importer. The US has become a leading oil exporter.

The current Democratic administration has once again picked up the pieces from the preceding Republican administration. Yet fickle Americans always get restless after 4 years and decide to vote for change – even when the progress is undeniable and strongly moving in the right direction. It would be madness to go back to the instability and daily chaos of the Trump administration after all the progress.

There have only been 6 presidents since 1946 to REDUCE the deficit (all Democrats):

- 1. Harry Truman: 92% top marginal tax rate. Reduced the deficit (from \$16B to \$6B) while paying down massive debt from WWII and the Korean Wars. Despite strong Republican opposition he expanded Social Security and disability benefits, established minimum wage, ended child labor and cut taxes on working middle class Americans.
- 2. John F. Kennedy: Kennedy reduced the deficit despite a recession (from \$7B to \$6B). He cut the top marginal tax rate to 70% and added credits for US investment. Expanded healthcare, Social Security and housing programs. Raised the minimum wage. Established the Peace Corps.
- 3. Lyndon B. Johnson: Reduced the deficit and left a surplus (\$1B deficit to a \$3B surplus). His "Great Society" programs funded education, scientific research, urban renewal, and fought crime, dramatically reduced poverty, and expanded social services, including Medicare for seniors.
- 4. Bill Clinton: Reagan had cut top tax rates from 70% to 28%, tripling the national debt, exploding deficits and income inequality. Clinton raised the top tax rates, reduced the deficit, and left the first surplus since 1969 (\$203B deficit to a \$128B surplus). His predecessor George W Bush's economic mismanagement and more trickle-down tax cuts for the wealthy left a record \$1Trillion deficit and a Great Recession.
- 5. Barrack Obama: Despite only 72 days of a filibuster proof majority, Obama passed stimulus stabilizing the economy and saving millions of jobs. He slightly raised taxes on the wealthy to ensure deficit reductions while also insuring 21 million Americans with the Affordable Care Act. He reduced the deficit by 2/3 at a record pace (from \$1.6Trillion to \$660Billion).
- 6. Joe Biden: Like Bush, Trump slashed taxes on the richest of the rich and squandered Obama's deficit reductions, leaving a \$3.8Trillion deficit. Biden's stimulus and policies saved the economy from recession and led to record job growth. By last year Bidens policies had already slashed the deficit by a record \$1.5Trillion.

For historical reference, in 2017 the Republicans passed a 10-year tax plan for America, signed by Trump. It heavily cut taxes on the richest of the rich and large corporations. It raised taxes on the middle class and small mom-and-pop businesses. It screwed all of us. It is set to expire in 2027. Trump has already told his billionaire buddy's his number one priority is extending that for another 10 years. That's what this is all about. Don't be distracted by the shiny object. All the BS social issues they use to distract and divide us: guns, gays, God, immigrants. They are used to make you angry and afraid. Distracted from the obvious. They are rigging the game against all of us hard working Americans.



Here are some of the corporate tax rates before and after the 2017 Trump Tax Scam Law – Verizon: before 21% after 8%. Walmart: before 31% after 17%. AT&T: before 13% after 3%. Walt Disney: before 26% after 1%. FedEx: before 18% after 1%. Who had to pay more so those Republicans could so generously give money to their corporate masters? You and I, and all the hard-working middle class of America.

In 2023 General Electric boasted \$7Billion in profits. How much do you think they paid in taxes on those profits? If you guessed \$1 that would be way too high. They got a refund of \$423Million.

This is what corporate welfare giveaways look like. 90% of all welfare goes to large corporations. The majority doesn't go to people in need. It doesn't help the hard-working middle-class, blue-collar workers like us. It goes to corporate welfare.

I am done with patience for members that get mad the unions support Democrats. You can vote for Republicans because you are afraid for your guns. Because you are afraid of the gays. Because you are afraid of people of color. Because you mistakenly think America was founded on Christianity and see a secular government that scares you. That is your prerogative and God bless you, you've got the right. But don't come at me and say you are doing it for the economy or the good of the working people of America. That my friends would be a lie.

Don't be duped. Don't fall prey to fear and loathing. That's all Trump is selling – hate and fear. He has no plans. He appeals to the basest of your emotions. If you aren't leading your life and every day with love and compassion for your fellow humans, you are wasting the day and your life.

As the busy construction season starts to wind down, The FTI of W&CNY's busy season is starting to ramp up. We are preparing for our Apprentice School and the busy training season. I am looking forward to seeing all of our Apprentices and Journey-people at our Training Centers throughout the Fall and Winter Seasons.

Our DC 4 Apprentices will be receiving their school schedules soon. The New York State Department of Labor (NYS-DOL), who our 13 Apprentice programs are registered with, requires a minimum of 144 hours of classroom related instruction each year for apprentices. Our Apprentices will come in for 1 week per month, for 4 months to fulfill the NYS-DOL requirement. While in school, the Apprentices will complete the required curriculum, required Health and Safety classes, and get hands-on training that relates to their craft. The apprentices are the future of our Organization. We need to mentor, educate, train, and treat our Apprentices, and all our Members, like our pensions depend on them... because they do! It is our duty, as Union members, to help and train our brother and sister members. Help us build our

leaders of tomorrow through mentorship.

The FTI of W&CNY is currently working on the Health and Safety and Journeyman upgrading training schedules for WNY and CNY. Please check dc4.org for training schedules and keep a look out for text blast with updates. If there are any classes you need or would like to see us put on the schedule, please call the FTI Office at 716-565-0112.

One Union, One Family, One Fight: One thought that sticks out to me from the 33rd General Convention is that we have some real power collectively. There was an abundance of talented leadership on display from our rank-and-file delegates up to our IUPAT General President James Williams Jr. We had a well-planned and intentional agenda that will steer the course for our next 5 years as an International. The resolutions passed will support us in adapting and growing as a union family. The speakers brought in from around the world were fierce labor advocates. What I have personally witnessed over the past 5 years is that politicians on both sides are leaning further into labor and that's because 7 out of 10 Americans are in approval of labor unions. District Council #4 has a responsibility to capitalize on this trend and provide more opportunities for our members and contractor partners. This influences every decision throughout our day and is at the core of what we aim to achieve in the organizing department.

The efforts DC4 has taken in our career fairs, digital marketing and overall outreach have had a positive impact on our numbers into the apprenticeship. The lists have become plentiful, and the Organizing Dept. has worked alongside FTI to help streamline the abundance of applicant interviews. In some areas we have put out record numbers of apprentices while we are flat in others. We need to continue pushing to our contractors the importance of employing and helping train the future of our workforce. Our industry, our livelihoods, and our retirement depend on it. If you look around our ranks the vast majority of our highly skilled men and women have come through our registered apprenticeship program. We continue our work with pre apprenticeship programs and bringing awareness to the careers in a skilled trade. DC#4 is leading the charge with our state and local officials establishing working programs throughout our jurisdiction. We had our 2nd "signing day" for Local 677 new apprentice Aiden Sullivan at Southern Glass. Starting a career in the Skilled Trades should be celebrated and we are happy to participate in acknowledging this life changing decision to join DC4 Glaziers. This Summer as a District Council we still faced shortages in qualified journey workers, but they were more manageable than prior 2 seasons. It is always a balancing act trying to sort supply and demand with workforce and upcoming projects however working across departments and with our contractor partners we will continue narrowing that gap.

October 18th is rapidly approaching which means our annual Glass & Glazing Forum is upon us. We have added an association meeting in the afternoon which will increase our contractor attendees. Our Glazier Reps, the FTI, & Organizing Depts. have been working together to make sure this is a successful event. It takes a lot of coordinated effort and constantly looking to improve turnout, quality and substance. We have participation from other DC's and IU staff that have interest in replicating what we do. As I've reported out in the past, one of the reasons we host these is to promote the Installer and Contractor (AGMT & NACC respectively) certifications in the industry. The specification has grown exponentially in NYS through our relationships and education. We are actively campaigning to push this language at the County level and have been working with our Executives and Legislatures to get them up to speed.

We will be kicking back into high gear with our Volunteer Organizing Committee & our monthly meetings after a short Summer break. This is an easy way to get involved with our Council & engaged in our communities. If you have interest in getting more active, please inquire with any FTI or DC4 staff and they will point you in the right direction. Joe Guza has done a great job in crafting digital newsletters, updating our membership with important events, and highlights in each area.

As Summer comes to an end, and the changing of the seasons is upon us, I encourage all of us to make some positive changes in our lives and for those around us. With the divisiveness of a federal election season, we should remember that we all have more in common than is perceived. I support any candidates that champion labor unions. Supporting and building relationships with these candidates is only the first step though. We need to hold them accountable in improving our market share, work conditions and economic security. I believe the election this year has a lot at stake for not only you and your family but what is at stake for workers and more importantly construction and the projects that are coming out throughout the country and more importantly in our jurisdiction for our members and contractors. In the last four years the bipartisan Infrastructure Bill was passed which will create many mega construction projects including the \$112 billion Micron Plant (20 yr. PLA) in the Syracuse Region and many other projects. There was also the Butch Lewis Emergency Pension Plan Relief Act which saved many multi-employer pensions including some of our own members pensions. As always, we have all candidates that seek endorsement from us fill out a question-naire and then meet in person with them and pick the best candidate that supports our issues that will help our members and contractors with more work opportunities and enhance laws that strengthen our union by including apprenticeship language, local hire language, protect prevailing wage or even add special requirements to specs like NACC/AGMT certifications. We only make recommendations after interviewing candidates that we feel will best suit us and the membership we represent by

supporting that type of language or legislation and/or special requirements. We have many Republicans and Democrats that we support as they have a proven track record proving they support such language and legislation previously stated.






































HOLIDAY SCHEDULE FOR CHECKS
